FULL RELEASE, WAIVER, INDEMNITY, AND HOLD HARMLESS AGREEMENT

In consideration for being allowed to participate and utilize the facilities known as LIBERTY PARK OF AMERICA the individual (or if that individual is a minor under the age of eighteen (18), the minor's parent/guardian) whose signature appears on the roster (hereinafter "Participant"), agrees to FULLY RELEASE, WAIVER, DISCHARGE, and COVENANT NOT TO SUE LIBERTY PARK OF AMERICA, its officers, officials, shareholders, employees, insurers, and, agents from any and all claims for personal injury, permanent disability, death, or property damage, including any and all claims involving an alleged defect in the premises arising out of Participant's use of the facilities whether caused by Participant's own actions, inactions or negligence or that of others.

Sports activities involve varying degrees of risk depending on the skill of the participants and the level of play. Each Participant is fully knowledgeable as to the risks of the sport in which the individual intends to participate and recognizes that there can be dangers associated in the participation and use of the facilities. Participant, states that he or she is in good health and has no knowledge of any infirmity which would impair ability or increase any risk. Participant further states that he or she has inspected the entire facility including the specific field conditions, playing surfaces, and/or obstructions associated with Participant's use of the facility.

Participant understands that he or she is participating and utilizing the facility at Participant's own risk and agrees to assume all risks of the activity in which Participant will participate. Participant recognizes that the facility is a multi-use sports dome and that other activities may be ongoing concurrently with Participant's use of the facility. Participant specifically assumes any and all risks associated with his or her participation in a multi-use sports facility, and accepts personal responsibility for any and all damages following an injury, permanent disability, death or property damage, not only from Participant's own actions, inactions or negligence, but also the actions, inactions or negligence of others.

Participant, agrees to INDEMNIFY and HOLD HARMLESS LIBERTY PARK OF AMERICA, its officers, officials, shareholders, employees, and agents from any claim asserted against LIBERTY PARK OF AMERICA, arising out of the Participant's participation and/or use of the facilities, whether caused by the actions, inactions or negligence of the Participant, LIBERTY PARK OF AMERICA, its officers, officials, shareholders, employees, and agents or others using the facility.

The releases, waivers and indemnities set forth herein are intended to be and shall be deemed interpreted, construed and enforced as the fullest, broadest and most complete indemnities, releases and waivers permitted by law or in equity. This document shall continue in full force and effect and shall not be merged, extinguished or modified except on the express written and executed agreement of Participant and Liberty Park of America. This Agreement shall be binding upon all of the Parties hereto and may be enforced against any signatory hereto and their respective successors and assigns.
