The following is a list of player eligibility guidelines for the Tournament.

COED UPPER:	No more than 3 USSSA Men's C tournament players allowed and no more than a total of 2 USSSA Women's C tournament players allowed.
COED LOWER:	No more than 3 USSSA Men's D tournament players allowed. No more than a total of 3 USSSA Women's D tournament players allowed. No Women's C players allowed.
COED REC:	No USSSA tournament players allowed. This is for BEGINNERS only. It is up to Liberty Park to allow or deny based upon rosters submitted.
